

# **IMMUNISATION AND VACCINATION POLICY**

# Introduction

Immunisation and Vaccination is the safest and most effective way of providing protection against diseases. Immunisation, defined exclusion periods and good hygiene practices reduces the potential risk of exposure within the early childhood environment. The NSW Government *Immunisation Toolkit* for early childhood education and care services guides our practice and provides resources and information to support families' access information regarding immunisation. NSW Health also provides guidance on recommendated vaccinations to lower risks of diseases and viruses.

#### AIMS:

- To maintain a current record of vaccination status of all children.
- To provide current information to families and educators on vaccine preventable diseases and the preschools expectations.

## **IMPLEMENTATION STRATEGIES:**

#### 1. Immunisation Records

Under the *NSW Public Health Act 2010*, an approved immunisation from the Australian Immunisation Register (AIR) must be provided in order for you to enrol your child.

- I. An **Immunisation History Statement** showing your child's immunisations are up to date (including if your child has a medical contraindication or natural immunity to some or all vaccines) or;
- II. An **Immunisation History Form** Catch-up Schedule used when an immunisation provider has certified vaccines given by another immunisation provider (i.e. vaccines given overseas) and/or organised to commence your child on a catch-up schedule for any overdue vaccines.

Other immunisation records, such as the Interim NSW Vaccination Objection Form, Blue Book, a GP letter or an overseas immunisation record are **NOT** acceptable.

#### 2. Immunisation Register

Under the NSW Public Health Act 1991 the Preschool must maintain a register of the vaccination status of all children. A register of each child's current immunisation status will be kept on the current enrolment list. Copies of immunisation records will be kept on file with each child's enrolment form in a secure location for 3 years.

#### 3. Accessing AIR Records

AIR Immunisation History Statements are automatically sent to parents/guardians after their child has completed the 4year old immunisations, but parents can obtain updated statements at any time (up to the child being 14years of age by:

## 4. Updating Records

Families will be reminded to update immunisation records via newsletters, emails or letters. Children re-enrolling each year will be requested to update their immunisation status. Children turning 4 years during the Preschool year must provide updated immunisation records as soon as possible. Failure to provide up to date immunisation status could result in a forfeit of your child's re-enrolment at the preschool.

## 5. Staff Vaccination

It will be recommended to educators that they maintain their immunisation status by being protected against influenza, mumps, rubella, diphtheria, tetanus, whooping cough, varicella and hepatitis A. Updates around vaccination are provided to educators as they become available.

## 6. Covid – 19 Vaccination

Based on the NSW Health guidance, **all staff** must be vaccinated with the minimum of 2 covid-19 vaccines, with boosters highly recommended and encouraged. A record of this will be requested.

**Students** must be vaccinated with the minimum of 2 covid- 19 vaccines, with boosters highly recommended and encouraged. A record of this will be requested.

Visitors, Volunteers and External Contractors are encouraged to be vaccinated.

**Children** are encouraged to be vaccinated if available to them based on the NSW health guidance.

This will be reviewed when appropriate to meet current recommendations and guidelines

## 7. Outbreak of Vaccine Preventable Diseases -

In the event of an outbreak of a vaccine preventable disease -

- a) All parents will be notified of the outbreak.
- b) The Nominated Supervisor must notify the local Public Health Unit (PHU)on: 1300 066 055, if any of the following diseases occur being Diphtheria, Tetanus, Pertussis (whooping cough), Haemophilus Influenzae type b (Hib), Polio, Measles, Mumps, Polio, Rubella or Meningococcal C.

#### 8. Information for Families and Staff

A copy of the current **NSW Immunisation Program Schedule** and the National Health and Medical Research Council's **recommended minimum exclusion periods** will be provided to all staff and families in the Parent Information Guide when they commence at the Preschool.

#### 9. Privacy of Records

Privacy regarding the immunisation status of all enrolled children will be maintained at all times. The immunisation status of enrolled children will only be provided to Public Health Unit staff upon request, for example, during an outbreak of a vaccine preventable disease. Officers of the Department of Education are authorised to inspect the *Immunisation Register*.
